Dear Parents:

According to state law, The Somerset Hills Board of Education must provide transportation to all students who reside at a location remote from school. Students who live "non-remote" from school, which is two miles or less from the elementary and middle school and two and one-half miles or less from the high school, may register for subscription bus service. Mileage is measured by taking the most direct route from the home entrance nearest the roadway to the closest public entrance of the school building. This letter has been sent to you because our records indicate that your home meets the mileage criteria for being "non-remote".

Please note that certain roads have been designated as walker roads by Board policy, depending on the grade your child is in. For example, a kindergarten child may be eligible for subscription busing, but a middle school child at the same address may not. Only the child referenced on the envelope is eligible.

If you wish your child (ren) to be transported to school next year, you must complete and return the enclosed application form along with a non-refundable fee of \$450 per child. The maximum family cost is \$1,000. All applications must be received in the district business office by June 20, 2016. After that date the only exceptions will be for families new to the district or for an emergency situation. If an emergency situation should occur, you must contact me. Registrations postmarked after June 20, 2016 will only be accepted if seats are available on an existing bus.

If you choose not to register for subscription busing, please return the registration form with the "not participating" box checked off. You may also decline by emailing me at pvail@shsd.org. This will help us in planning the year's bus routes.

If your child is eligible for the free or reduced lunch program, you may request a waiver of this fee by contacting me at 908-204-1930 x 1120 or pvail@shsd.org. Please contact me with any other questions.
